Prior to that, he served as the Chief Administrative Officer at the Illinois Department of Innovation and Technology (Dolt), where he led a newly unified enterprise of 1,500 employees spanning 50 agencies, boards, commissions, and other entities. He oversaw \$1 billion in annual spending and a complete digital transformation of state government. He earned his Juris Doctorate from Saint Louis University School of Law in 2010, and his Bachelor of Science from Indiana University, Kelley School of Business in 2007.
