We may recognize up to three winners within each category to award projects located in the City of Chicago, suburban Cook County/collar counties, and statewide. The "other" category encompasses those projects that helped transform the local economy, but simply don't fit into one category.

The awards will be presented during the Illinois Chamber's annual meeting on Thursday, September 20th in Chicago. Winners will be notified in July and invited (as a guest of the Chamber and IEDA) to the awards banquet to receive the award in-person.

All submissions will be reviewed by a subcommittee of the Illinois Chamber of Commerce and the Illinois Economic Development Association.

The submissions will be judged based on a mix of quantitative (total private investment, jobs created/retained, average wages) and qualitative (unique contribution, creative public/private partnership, low environmental impact) criteria. To be clear, this is not just about the biggest projects with the most state incentives. It is an opportunity to recognize projects that have a large impact on the community. I think we can all agree that those kinds of projects come in different shapes and sizes.


