Benjamin Brockschmidt, Vice President of Policy and Executive Director of the Infrastructure Council participated in a press conference with Governor Bruce Rauner, Illinois Environmental Protection Agency Director Alec Messina, and others to announce the first part of distributing funds allocated to Illinois from the Volkswagen Environmental Mitigation Trust. Illinois' initial allocation of funds is \$108 million to be used to fund mobile source projects with all funds to be used for projects that reduce emissions of nitrogen oxides in Illinois. The Chamber worked closely with environmental groups and other business organizations to ensure that the first steps of the plan reduce necessary emissions but help move Illinois forward.

STONEWATER ADDRESSES SUSTAINABLE ENERGY



Energy Council Executive Director Katie Stonewater gave a lecture at the University of Illinois-Chicago Summer Institute on Sustainable Energy (SISE). SISE is a two-week long seminar designed to provide the next generation of professionals the multi-disciplinary knowledge and experience to address the rapid changes facing the energy industry and society. Katie gave a civics lecture to the students in the context of energy policy, speaking to how government works, how it impacts them, and why they should be engaged. The lecture challenged students to understand how they can and should work with government to advance their business and policy goals, and the most appropriate ways to achieve that.

CHAMBER CALLS FOR ACTION BY GOVERNOR RAUNER

The Illinois Chamber requested Governor Rauner act on 14 pieces of legislation from Spring session. Three actions that stood out included his amendatory veto on SB 904 (Hastings/Hoffman). This bill would have allowed medical providers to pursue a 1% per month interest penalty on unpaid workers' compensation medical bills in circuit court. While there were elements of the legislation that merit attention, other provisions will work against the employer community in assuring medical services are necessary and the charges are reasonable.

The Governor also granted the Chamber's recommendation to amendatorily veto SB 2921 (Cunningham/Welch). This bill would have diverted \$5 million out of the unclaimed property funds to purchase and renovate a building. Idle dollars in the unclaimed property fund are earmarked to pay back state pension debt.

Lastly, the Governor did not sign SB 1737(Munoz/Hoffman), a bill advocated by the Chamber. Among other things, SB 1737 would have updated the captive insurance regulatory structure to help Illinois overcome its competitive disadvantage in this area. The Governor's amendatory veto eliminated from the bill various workers' compensation rate regulation changes and the new regulation of short-term health insurance policies.
